The publishers will publish the work at their own expanse and risk and shall have during the period of this agreement exclusive rights to produce, publish and distribute the work and its subsequent editions and/or portions of the work throughout the world, in the language its written and its translations in any language desired.
- 4. The author(s) certify that the copyright of this work rests with them and no part of this work is taken, copied or plagiarized from any other sources without due acknowledgement and in no way infringe the copyright law of a third person. The author(s) agree to transfer and assign this copyright to Narain Publishers Private Ltd. For the duration of this agreement without any restriction on its use, including co-publication, translations, adoptions, as may be considered necessary by the publishers to promote the work.
- 5. Author(s) agree not to assign the copyrights to someone else during the period of validity of agreement with Narain Publishers Private Ltd.
